

## **EXHIBITOR AGREEMENT RULES AND REGULATIONS**

Exhibit Size: 8' wide x 6' deep

Exhibit Space: Components and signs will be permitted to a maximum height of 8'. All components must fit into booth size purchased. Display materials over 4 ft. high must be confined to the booth area and at least 5 ft. from the aisle line.

Shipping: Additional shipping and handling charges may apply, and are due payable to Omni Interlocken. Packages may arrive at Omni Interlocken from 8:00am-4:00pm MST, Monday-Friday, March 26-31, 2025. Shipments received any other time will be rejected. Alcohol: Alcohol Sales/Distribution at exhibitor booths prohibited.

Announcements: Microphones and amplifiers are not allowed.

Cancellation Policy: 2025 Exhibitor Cancellations must be provided to NFCA in writing, via fax or email. Cancellations prior to February 28, 2025, may receive a 50% refund. Cancellations after this forfeit any refund.

<u>Cash or Credit Card Sales</u>: Cash or Credit Card Sales are prohibited during the show.

Choice of Law, Venue, Attorney's Fees: This Contract is governed by the State of Illinois. Venue for any dispute arising out of or related to this Contract shall be in DuPage County, Illinois. The prevailing party in any dispute arising from or related to this Contract shall be entitled to its attorney's fees, costs, and expenses incurred through mediation, litigation, or appellate proceedings.

<u>Conflicting Events</u>: Conflicting Events at Omni Interlocken are prohibited during show/seminar hours.

Consent to Be Photographed: As partial consideration for my attending this event, I give the National Fireproofing Contractors Association (NFCA), its licensees, assigns, successors in interest, and legal representatives the irrevocable right to use any photographs and/or video of me taken at this event.

<u>Electric</u>: 110v electric connections must be pre-ordered through NFCA. On-site electrical orders could face premiums and cannot be guaranteed.

Entertainment: Exhibitor may operate games, raffles, and entertainment in the booth with prior NFCA approval.

Exhibit Staffing: Exhibits are expected to be staffed with exhibitor personnel during all trade show floor hours. Based upon the level of membership or registration selection, Standard Booths include complimentary registration for up to three (3) free attendees to WoL '25. All other exhibit staff must pay the registration fee. All exhibit staff must be registered. Booths not staffed with exhibitor personnel during all exhibit hours may lose future exhibit space.

<u>Exhibitor Raffles</u>: NFCA can announce winners of raffles held at individual exhibitor booths during the NFCA Annual Dinner.

"Give Away" Items: Razor blades, knives, etc. prohibited.

<u>Hospitality Suites</u>: Hospitality Suites are acceptable provided they are not open during event/exhibit/seminar hours. NFCA approval required.

Liability: It is agreed that Exhibitors will assume responsibility for any damages to Omni Interlocken and their own exhibits. The Exhibitor further agrees that neither NFCA, nor its employees, agents, or representatives shall be liable and that the Exhibitor will release, hold harmless, and make no claims for any reasons whatsoever including negligence (but excluding gross negligence or willful/wanton conduct), against the NFCA, its employees, agents or representatives for: (1) loss, theft, damage or destruction of goods or displays: (2) any accident or injury to or death of the Exhibitor or the Exhibitor's employees, agents or representatives; (3) any damage to Exhibitor's business by reason of the failure to provide space for the exhibit or the removal of the exhibit; (4) any other action of employees, agents or representatives of NFCA; (5) the failure to hold the event as scheduled as a result of Coronavirus (COVID-19) or similar viruses or illness requiring quarantine, local, state, or federal emergencies, acts of God, fire, flood, riots, or any other causes beyond the control of NFCA, Omni Interlocken, or any exhibit service contractor that may render any exhibit area unusable.

Machinery: Machinery may be displayed but may not be operated.

Reservation of Right to Make Changes: Any matters not specifically covered herein are subject to decision by NFCA, and NFCA reserves the right to make such changes, amendments and additions to these rules as considered advisable for the proper conduct of the exhibit, with the provision that all Exhibitors will be advised of any such change.
